TERMS AND CONDITIONS OF FUNDING FROM THE MALAY/MUSLIM COMMUNITY DEVELOPMENT FUND (MMCDF)

In accepting the Approved Grant Amount, the Applicant hereby confirms, undertakes, acknowledges and agrees as follows:

- 1 All information set out in the Application Form (including in relation to the Project) remains true, correct and accurate as of the date hereof and the Applicant has not concealed any information or changes to any information in the Application Form that would render it untrue, inaccurate or misleading;
- 2 The Applicant shall use the Approved Grant Amount strictly for purposes of the Project;
- 3 The Applicant shall strictly adhere to the deliverables and timelines set out by CLF Secretariat;
- 4 Non-compliance with the stipulated deliverables and timelines may result in a delay or refusal in the disbursement of the Approved Grant Amount;
- 5 Only duly completed submissions of the deliverables in such format as stipulated by the CLF Secretariat (in its sole and absolute discretion) shall be considered for purposes of the disbursement of the Approved Grant Amount;
- 6 Notwithstanding the Approved Grant Amount and the disbursement schedule set out above, the final quantum and disbursement of the Approved Grant Amount shall remain at the CLF Secretariat's sole and absolute discretion and the CLF Secretariat may make such adjustments to the Approved Grant Amount as it deems necessary including withholding or recovering any disbursements already made to the Applicant in the event that:
 - a. there has been a breach by the Applicant *o*f any of the terms of the LOA or these terms and conditions of funding; or
 - b. the execution of the Project has, in the CLF Secretariat's sole determination, been unsatisfactory;
- 7 The Applicant (through its authorised representative(s) who was personally involved in the execution of the Project shall attend the CLF Sharing Events for purposes of sharing the Applicant's experience in executing the Project;
- 8 The Applicant will acknowledge and recognise the receipt of the Approved Grant Amount from the CLF Secretariat by expressly stating in clear fonts, with reasonable visibility and appropriate placement, the words: "*Funded by the Community Leaders Forum (CLF)*" and attaching the Community Leaders Forum ("CLF") logo alongside such wording in all the published materials, collaterals and announcements for the Project [samples of which was enclosed in the Application Outcome Email];
- 9 The Applicant shall not use the CLF's, MMCDF's or Yayasan MENDAKI's logo (or make any references to the CLF, MMCDF, the CLF Secretariat or Yayasan MENDAKI) for any other purposes unrelated to the Project and the Applicant undertakes to comply with any such directions that the CLF Secretariat and/or Yayasan MENDAKI may give in relation to the Project, the Approved Grant Amount, the terms of this letter and/or the use of the CLF's or Yayasan MENDAKI's logo (or any references to the CLF, MMCDF, the CLF Secretariat or Yayasan MENDAKI);
- 10 The Applicant shall:
 - at all times in the execution of the Project comply with all applicable laws and will obtain and maintain all necessary consents, approvals and/or permits prior to the conduct of the Project;

- at all times in the execution of the Project maintain adequate insurance policies covering any liability that may arise from its execution of the Project and maintaining the highest levels of safety standards and precautions in the execution of any activities pursuant to the Project;
- c. maintain the highest levels of integrity and prudence in utilising the Approved Grant Amount which the Applicant acknowledges to be community funds; and
- d. fully indemnify Yayasan MENDAKI and its CLF Secretariat including their respective employees, agents and servants against any and all liability including but not limited to any losses, fees, costs (including legal costs), damages, expenses arising from the Applicant's breach of any terms of the LOA and this terms and conditions or any failure, neglect or omission by the Applicant in its execution of the Project;

11 The Applicant:

- a. shall grant Yayasan MENDAKI and its CLF Secretariat to use, mention or feature the Applicant's name, logo, description of business, details of the Project in their advertising, marketing and promotional materials and activities;
- b. agrees that Yayasan MENDAKI and its CLF Secretariat (or their duly authorised representatives) may attend and take photographs and videos at all events related to the Project which may capture the name, image, photos, personal data and/or likeness of the Project participants, the Applicant and its employees, agents or authorized representatives, and the Applicant consents and shall procure the consent of the participants, its employees, agents and authorised representatives for Yayasan MENDAKI and its CLF Secretariat to use all such photographs and videos in their respective advertising, marketing and promotional materials and activities, including on their website; and

- 13 The Applicant acknowledges and agrees that the terms of the LOA and these terms and conditions of funding shall be governed by the laws of Singapore.
